2024 has been a year of new beginnings for the Financially Assisted Social Prescribing (FASP) project. Since the launch of the project in September, we have grown and evolved from our learnings. During the first quarter of this four-year FASP project, the team established three integral project components: the Advisory Committee, the Financial Assistance Working Group, and the Social Prescribing Service Coordination Collective.

Advisory Committee

Financial Assistance Working Group

The FAWG is comprised of subject matter experts, people with lived experience, and community leaders. Members determine inclusion and exclusion criteria of the upcoming CRC Community Health Grant to ensure that the grant is as low barrier as possible while maintaining its efficacy and legitimacy.
