



2023 **FIRES UPDATE**

DECEMBER 31, 2024

In 2023, British Columbia experienced one of the worst fire seasons on record with more land impacted than even the previous record-breaking years. High temperatures and ongoing drought conditions created challenging fire conditions in the province. Thousands of people were under evacuation orders and alerts in many parts of the province, resulting in a Provincial State of Emergency.

Recovery and mitigation efforts following a disaster of this size takes time. The Canadian Red Cross continues to offer personalized recovery support to help people impacted by the fires. This includes housing repair and reconstruction support to those most impacted by the fires, working closely alongside people and families at their own pace for recovery.

Emergency relief for individuals and families	Following the fires, households with the greatest needs received support from the Canadian Red Cross in multiple ways. The emergency relief provided by the Red Cross after this disaster included registration, lodging, clean-up kits, cots, blankets, hygiene kits, water, information and referrals, as well as psychosocial and well-being support.	\$0.03M	\$0.03M
Recovery assistance for individuals and families	The Canadian Red Cross is offering personalized recovery support to the people most impacted by the 2023 wildfires in British Columbia. This includes support for people whose primary residence was destroyed or incurred major damage. Red Cross support may include support for temporary accommodations, helping those impacted with planning their return home, understanding insurance and community resources, providing information and referrals to help with decisions, as well as providing financial assistance to access mental health services. Support is also being provided for people whose primary residence sustained major damage or was destroyed as a result of the wildfires to repair or rebuild their home. This includes financial assistance for eligible homeowners to help meet their immediate needs and to assist with costs related to housing repair and reconstruction.	\$5.12M	\$5.12M

UNDERSTANDING THE NUMBERS

Grand total of funds to date:

This includes the total funds donated and any earned through interest.

Allocation of funds to date:

This is the projected budget across each area of spending for the grand total. The allocations reflect the needs of the people and the communities that have been identified to date.

Spent and committed to date:

These are the funds that have been already spent to assist those impacted by the 2023 wildfires in British Columbia, as well as funds that have been committed with authorized contracts or agreements for recovery projects or initiatives, where applicable.

Cost of fundraising and trust fund management:

The costs associated with this emergency appeal — including cost of fundraising and trust fund management — will not exceed eight per cent. The cost of fundraising is associated to the total funds donated. These costs can include donation processing fees; credit card and bank fees; service fees for call centres and digital platforms; and ongoing communications and reporting to donors. Trust fund management costs are for the management of the overall trust fund for this appeal.
